I agree to accept all responsibilities for the risk, conditions and hazards, including lift towers and snow making equipment such as guns, hydrants, and hoses, which may occur whether they be known or unknown.

BEING FULLY AWARE OF THE RISK, CONDITIONS AND HAZARDS OF THE PROPOSED ACTIVITY AS A COMPETITOR, COACH, OFFICIAL, PARENT OR GUARDIAN, I HEREBY AGREE TO WAIVE, RELEASE AND DISCHARGE ANY AND ALL CLAIMS FOR DAMAGES WHICH MAY HEREAFTER ACCRUE TO ME AS A RESULT OF MY PARTICIPATION IN ANY PARK ACTIVITY, AGAINST ANY PERSON OR ENTITY MENTIONED ABOVE, BUT NOT LIMITED TO, WHETHER SUCH INJURY OR DAMAGE WAS FORESEEABLE OR NOT FORESEEABLE.
