In this regard, I agree to be bound by the provisions of Mass. G. L., Ch 143, Sec 71P or NYS Gen Obligations Law, Article 18, as applicable.
- I understand that in purchasing this season on-mountain pass that it will be issued to the participant named herein and is valid for the 2010-2011 winter season. I further understand that on only one occasion during the season will a day ticket be issued in respect of a forgotten pass. Additionally, I understand that a \$30 fee will be levied in respect of a replacement pass.
